
Sub: Compliance against your objection dated 08. 06.2019 .

Sir,

With reference to above, the following points have been complied by us as under:-

1. **Shed allotted is not utilized for the purpose:-**That, our Project of mfg of fishing net was established in the Shed No. C6 at I/E Jagatpur (old) for more than five years. But due to road facilities to the said I/E , the project work held up seriously and we forced to shift the same to Mancheswar I/E along with some machineries. The same problem has not yet been solved nor any imported materials through loaded vehicle from outside is not entering to the Indl Estate till now. Besides the flood occurred in 1999 submerged the water in the Indl Estate as a result of which the bank/Finanacial agencies refused to provide advances/loans for establishment of our project. The matter has been intimated to IDCO Authorities during the year 2007 for consideration (**copy of our letter dated 21.12.2007 already uploaded**) . Therefore we forced to start another project during 2012 for mfg of SS Pipes , SS Cabinets, furniture & Kitchen equipments with the approval of DIC ,Cuttack-EM-II No.210121200001(**copy already uploaded**). As per your letter No. 2190 date 11.7.2012, we have already submitted required documents to IDCO for effecting such changes in favour of M/s Cholomondal Fibres (Orissa) (P) Ltd at I/E Jagatpur (Old), which may kindly glanced through.
2. **Change of constitution of firm made unauthorisedly:-** That CGM ID, IDCO requested ROC, Orissa, Cuttack vide **his letter memo No.15215 dated 07.08.2008** regarding information on constitution of the firm. The same has been complied by ROC on dated 07.11.2008. Accordingly the change of constitution of the firm may be taken into consideration.
3. **Willingness to regularize excess land:-**We do hereby upload the willingness in affidavit format to regularize the excess land as per IDCO norms.
4. **Water Agreement :-** We agree.

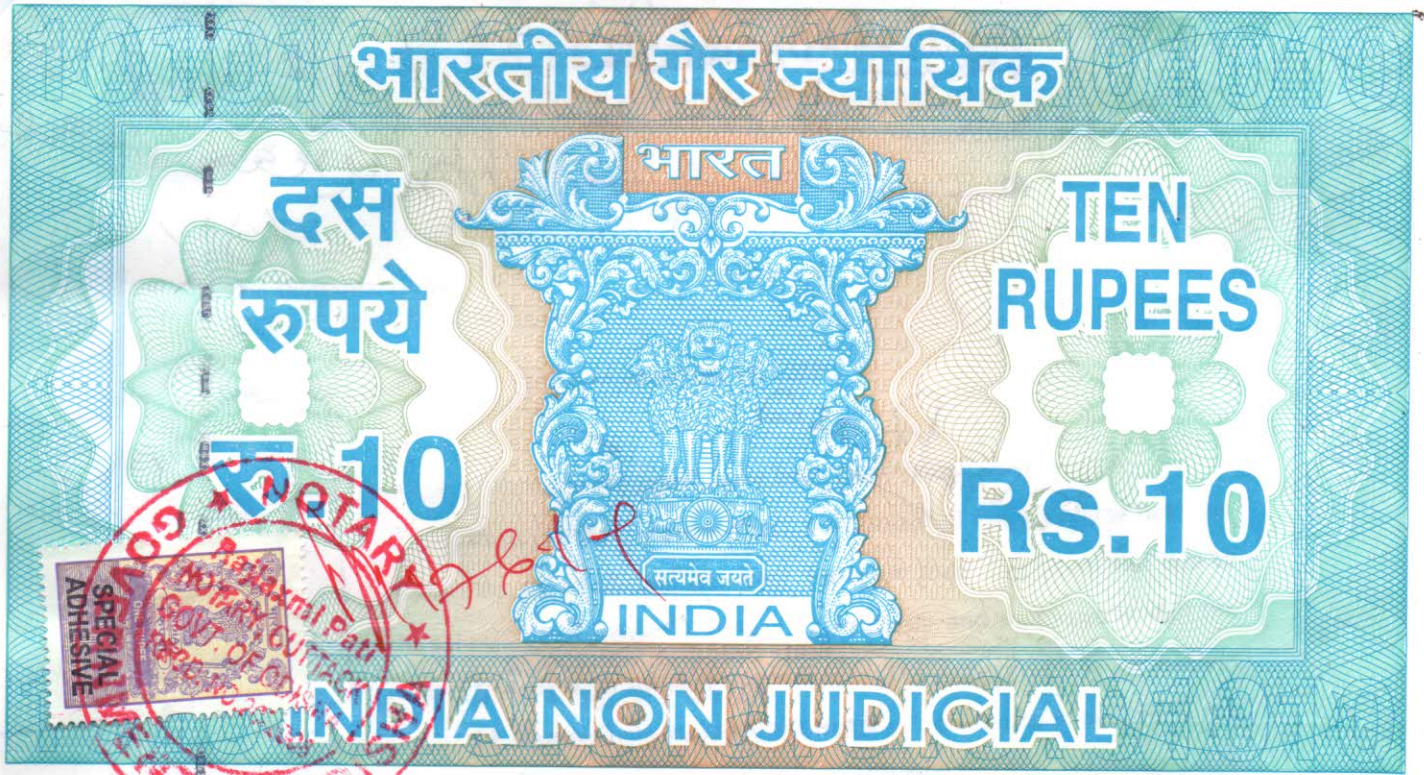

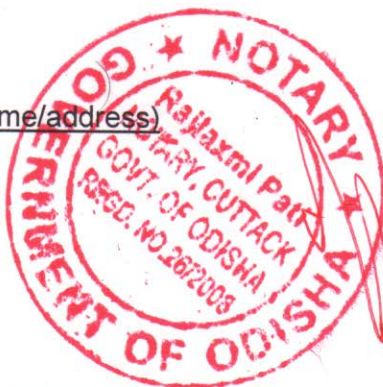
